NOTICE: INVITING TENDER FOR AVIATION FUEL

1. Sealed tenders are invited from reputed companies/ firms for providing aviation fuel (ATFK-50/ Jet-A/ Jet-A1) during Indian Naval aircraft operation in Soekarno Hatta International Airport, Jakarta in end Mar 24/ April 2024.

Note: Required qty of fuel will be as per actual.

2. The bidding companies/ firms should have a PT/CV registration and VAT registration in Indonesia.

3. The bidding companies' firms should submit documentary proof of providing aviation fuel to foreign military aircraft/ international flight.

4. **Validity of Bids.** Bids shall remain valid and open for acceptance for a period of 90 days from the last date of submission of Bids.

5. **Earnest Money Deposit (EMD).** EMD of 3% of estimated value of the contract in the form of Bankers Draft/ Bank Guarantee having validity of six months drawn in favour of the Embassy of India, Jakarta has to be submitted along with tender bids. Bids not supported by EMD will not be considered. EMD is liable to be forfeited if the tenderer withdraws, impairs or derogates from this tender within the period of validity of this tender. EMD of unsuccessful bidder shall be returned soon after the completion of tendering process. No interest is payable on EMD.

6. **Performance Guarantee/ Security.** At the time of award of contract, the companies shall be required to submit performance guarantee in the form of banker's cheque, bank draft or

bank guarantee equal to 5% of the value of the contract. The performance Guarantee shall remain valid for a period of one year beyond the date of completion of all contractual obligations.

7. The fuel sample sealed in a container should be provided by the Fuel company provider to be kept in the custody of the Embassy.

8. Since the fuel cost is variable, the agency should ensure that the cost of fuel should not exceed the average market rate on the date of refueling of the aircraft

9. No advance or down payment will be made for supply of fuel.

10. Bills would be settled in full through bank transfer on submission of all documents such as invoices, delivery receipts and user acceptance certificates after departure of the aircraft.

14. The bids would be opened at 11:00 Hrs. on 04 Mar 2024, by a committee comprising officers of this Embassy. Interested parties are welcome to send one representative for opening of the bids in the Embassy.
